## LEGAL NOTICE

### *Teeter v. Easterseals-Goodwill Northern Rocky Mountain Inc., Case No. 4:22-cv-00096-BMM*

A proposed settlement has been reached in the class action lawsuit against Easterseals-Goodwill Northern Rocky Mountain, Inc. (“ESGW” or “Defendant”) related to a data security incident which Defendant discovered on or about July 20, 2022, and notified potentially impacted individuals on or about September 16, 2022. The lawsuit claims Defendant is legally responsible for the Data Security Incident, where personally identifiable information stored within Defendant’s information network, including, without limitation, names, driver’s license numbers, medical treatment information (these types of information, being thereafter referred to collectively as “Protected Health Information” and “Personally Identifiable Information” or “PII”) of patients, clients and/or other individuals may have been accessed and exfiltrated by unauthorized individuals. Defendant denies the claim and denies that it did anything wrong.

**You are receiving this Notice because you may be a Settlement Class Member.** The Settlement Agreement and more information about the lawsuits and Settlement are available at [www.ESGWDataSettlement.com](http://www.ESGWDataSettlement.com) or by calling toll-free **888-231-9068**. If you do not want to be legally bound by the Settlement, you must exclude yourself by March 6, 2024. If you do nothing, you will remain in the class, you will not be eligible for benefits, and you will be bound by the decision of the Court and give up your rights to sue ESGW for the claims resolved by this Settlement. If approved by the Court, Settlement Class Members who submit valid and timely claims can recover: (1) Compensation for documented Ordinary Losses up to one thousand five hundred dollars (**\$1,500.00**); (2) if you were a victim of actual documented identity theft, Compensation for certain Extraordinary Losses up to five thousand dollars (**\$5,000.00**); and (3) one year of identity monitoring.

The Court will hold a Final Approval Hearing on **April 11, 2024 1:30 p.m.** The Court will consider whether the Settlement is fair, reasonable, and will consider any objections.
